### 5. Consideration of the Financial Statements

### Financial Report:

- Club is growing. Managing a 280k budget every year. Total revenue was \$279k and expenses were \$282 with a net loss of \$3k. Actual profit is \$37k from the sale of the club van and trade in of truck for the year. Received the community gaming grant again which brough in \$36k and awarded again. Rally together grant for \$4000 and not all spent this past year.
- Lots of expenses for vehicle repairs last year. Received subsidy for school program.
- Also able to get a club credit card for centralized way of club purchases.
- Contingency fund added for this year. Just recently started, it's on the balance sheet, not the P/L sheet. A bit small right now but growing and working on how to make it work.
- Question on whether to set money aside for depreciating truck. Tight year with coach uncertainty. Might have to actively fundraise and get sponsorship for this.
- Question on Dave Battison Fund \$8000 cost for administering the fund. Think that was what we had paid butchers block for the fundraising.

## 6. Director's reports

- a) **Membership report.** Welcoming Jim Meldrum to assist going forwards. Last year, numbers were significant. Numbers consistent but growing. Jeff revied membership numbers.
  - 141 kids in the Rabbit Skill Development Program
  - 51 New to JRabbits
  - 40 kids in Devo Track Attack programs
  - 25 kids in the Junior Race program
  - 43 participants in the Masters Rec program
  - 17 Masters Racers
  - 384 registered under family designation
  - 38 single adult memberships
  - 25 senior memberships
  - 239 female members
  - 220 male members

### b) Skill Development Program Report:

- Overall, it was a great season!
- We ran 17 programs (6 on Saturday, 11 on Sunday) across Bunny Rabbits, Jack Rabbits L1-4, Youth Learn to Ski and SNAP (no FIT program in 2023).



# **SNSC Board Meeting**

- 136 children registered (down a bit from 152 the previous year; we are currently at 135 for the 2024 season)
- 22 coaches (10 were new in 2023)
- Beckie Scott Sprints were held on Feb 25 & 26; 60% of Bunny Rabbit and Jack Rabbit kids participated.
- Thanks to Mike Tunnah for officiating!
- Year-end celebration was held on March 18th included great games for all kids and everyone had fun!
- Parent volunteers organized everything (thank you Ceri, Stefan & Faye) including hot chocolate and cookies for families after the event.
- Signup genius helped recruit volunteers for SDP-related tasks and activities; we appreciated everyone's support.
- We are looking forward to another great season ahead!

### c) Rick Morson Ski School Program Report

- Huge Thank You to Jamie Purves for his coordination. Welcome to Sarah Devenish.
- Approximately 550 students received a set of 3 lessons. Under our equity initiative, 112 of those students were fully subsidized. \$8474.00 was used to provide rentals, trail passes and instruction.
- Most of the students received 3 lessons, some received 2 lessons.
- Lessons were provided by 8 different instructors
- \$5000.00 Equity Initiative grant from Nordiq Canada, funded by Sport Canada, which was used to subsidize equity deserving students. Rick Morson and his affiliates donated about \$5000.00 to the equity initiative funds.

## d) Coach Development Report

- 288 coaches on the club coaching database
- Last season(2022-23), SDP, school program and masters recreation program recruited 20 new coaches to the club
- Worked closely with SDP coordinators and school program coordinator with new recruits and information on required NCCP coaching courses, ensuring that all coaches in club programs meet minimum coaching requirements
- Provided online ICC + CC course information to new coaches in training
- Ongoing updating of coaching database, including provision for active coaches sheet; 72
  active coaches last season
- SNSC hosted a successful NCCP Community Coaching CC workshops- January 21-22, 2023 at MWSR - 16 new coaches participated
- Nov. 2022 and Spring 2023- sent 4 race coaches (devo and juniors) to advanced level of NCCP coach training.

- Our Fund Development position remains vacant.

- Regional Coach Grant \$5,500
- Nordiq Canada Equity Grant \$5,000 (Ski School)

- Club Sponsorship for events: \$3925 (Loppet)
- Dave Battison Fund: \$13, 201.00 (carried over from 2021-2022 and not topped up in 2022-2023)
- Rick Morson & Susan Carson are continuing to support the school program- \$5000.00
- Our annual Nordic Canada Campaign: \$7851.00
- Other fundraising efforts: \$ 5530.00 (Gaming 50/50 raffle)
