a. Head Coach Report – Andrea

Recent Activities

- December Camp, 3 days of excellent participation, technical development, time trial, agility, mental skills, intro to specific strength, overall huge success, 14 coaches involved

- SDP coach refresher dates set: Jan 14, 1-3pm classic, Feb 25, 1-3pm skate
- BC Cup #1/CWG Trials 50 racers, collaborated with Sovereign Lake/Toby Creek, excellent weekend considering weather, race format (classic sprint, klister conditions), very large group of new racers/families, very happy with capacity growth of both coaching team and wax team, great race results as well. Good event overall.
- Assisted in organizing local accommodation for group of Chilean athletes who wanted to come to train with us prior to World Jrs in Whistler, unfortunately plans changed they are now not coming prior to Worlds, but may have 2 come here after the Worlds

b. Club Coordinator Report – Michelle

- viaSport Rally Together, Sport Participation Grant expecting to receive news any day
- Met via Zoom with confirmed Chiefs for Coast Cup on Dec 29. More Chiefs to be confirmed. Devos and Juniors to organize the Coast Cup. Tentative meeting set for Jan 5 at 7:30pm. **Big focus is finding volunteers for this race**. With the turnover of long-term volunteers who have retired their roles, we need to attract new volunteers and I have been advised that for successful delivery of races it is recommended that volunteers especially Chiefs are trained as Level 1 and Level 2 officials. This summer and fall will be about ensuring training is offered and completed and that we retain new volunteers for the future of being able to host races and operate the club smoothly, It was also recommended that one of the board positions be a Director of Officials. Putting together packages for the weekend racing.
- Faq's page is growing based on emails and questions that come in.
- Newsletter call out went out on Dec 29 for January newsletter content. Content in Sync folder, Communications, Newsletter, Jan 2023. Almost ready to go.

- Met with Jon and Wendy Dec 16 about fundraising goals. For 2022-23, focus on a 50-50 raffle and the Nordic Annual Fundraising (support the van or support our athletes to race in BC) Aim for \$8000 as our target (\$2500 for 50-50 and \$5500 for Nordic Canada Annual Fundraising Campaign)

Here are some of the items that the funds help pay for:



- **Coach and officials training**. All coaches are volunteers and, in order to provide the club with a good program, the coaches need regular training. The club also organizes or assists in organizing several cross country ski competitions over a season that require trained officials.
- **Staffing**. As the club has grown, in order to be successful, we have found a need to start paying for some positions, such as part-time coaches and a part-time registrar and administrator.
- **Equipment**. This not only includes items like our skating skis, ski poles and wax, but also administrative items like computers, software, our web site and equipment used for club events and ski competitions.
- **Travel**. This includes the subsidies for the race team trips and for expenses for the executive members attending the annual Cross Country B.C. Club Workshop and AGM.
- **Competition and Clothing Subsidies**. In order to keep children involved and excited about being part of the club, and to encourage their participation in the sport outside of the regular sessions, the club often subsidizes some events and club clothing.

b. Treasurer's Report

- Wendy and I met to try and better line up the quick books profits and losses with our budget spreadsheet and it's proven to be a big task. Hard to get a good picture of where we are at until end of year.
- \$103 in operating, \$26,500 in gaming.
- I have attached both (not sure if I did it right for the spreadsheet budget) but it's not at a point of giving us a good picture of where we are. Sticking to budget for now. Fundraising will be bringing in some money.
- VIMSS centre made error on taxes for usage for total was corrected to \$6300 from \$6900 and change.
- A few grants came in. Nordic Canada Sport Equity Fund (School Program). General Donation [Action: need to figure out who made the donation: Wendy will send contact for Christa so Carolyn can figure out who], Kal Tire amount for Roller Skis
- P/L report in Sync.
- Will be helpful to have specific program budget, that make up larger budget (like ski school budget). Look at doing this for next season so more organized and prepared and have line items better organized.
- Open for more support on the budgeting/treasurer
- Comments re school program a helpful way to see school program budget specifically.

c. Communications Report

- Michelle has been doing the newsletter. Geoff is helping on social media.

d. Fundraising Report

- Need to dedicate a space in the newsletter for donors who put together the timing hut. Need a separate piece for the thanks to the donors.
- Community Services Recovery Grant is open. Broad Canadian Gov Grant for pandemic recovery. They have streams for "building capacity", might be a good use of Kathleen's time to apply for the grant. Up to (+) \$10,000. Can be about supporting people, and staffing piece. Also about investing in systems and processes and create better internal working. Due at the end of February. Wendy suggests applying and using Kathleen's time.



• Paid \$2000 up front, on hourly rate. Has developed a resource inventory for fundraising plan going forwards.

e. Coaching Report

Coaching recruitment

- update- 15 new "coaches in training" have been recruited for the NCCP on-snow Community Coaching course to be held on January 21-22, 2023 at MWAR- nordic (plus 4 volunteer or bunny coaches)
- Continue to send reminder notices to "coaches in training" to complete all requirements, including 2 online NCCP courses, CRC, and Nordiq Canada coaching license ongoing till Jan 21/22 weekend

Coaching courses

- NCCP Community Coaching CC workshop January 21-22, 2023 (as noted)
- Coaches refresher courses to be held Sat January 14- classic, and Sat February 25skate

Coaching database + CRCs

- Ongoing review of current active coaches for CRC status and when required, request coach to update CRC (online, easy process)
- Add "new coaches in training" to database once CRC clearance letter arrives

Nordiq Canada coaching licenses

- Follow-up with all program coaches (rabbits, school, race and masters rec coaches) to ensure all have annual Nordiq Canada coaching licenses
- Action: update coach database with coaches NC licenses

OTHER

- New initiative: created a Nordic Ski Lab (NSL) group subscription for race coaches and masters rec coaches to support coaching development; group subscription will be funded by current subscription holders and individual fund raising by some club directors; intention is to evaluate the utility, satisfaction and effectiveness of coaching development using NSL and consider proposal to the Board for full funding. Current Nordic Ski Lab group subscription for 20 coaches is \$22.50USD/each or approx \$642.50Cdn in total.
- <u>Discussion</u>: not in the budget for this year. As a way to thank coaches for time, we can pay for these memberships. Have asked for coverage in Rally Together Grant. It ends up \$600-700 to support 20 coaches with subscriptions. Chris will generously donate some funds. Wendy will donate some funds for this. Will be covered by private donations for this year. Coaches will have access to this resource. Chris will bring the motion for funding going forwards. Thank you Chris and Wendy.

f. Skill Development Program Report

- We are looking forward to our first weekend of programs on January 14-15. Introductory emails went out to coaches and parents/guardians of program participants. We asked coaches to email families to introduce themselves before January 14.
- We have 3 volunteers to set up the ski playground on Saturday and 1 volunteer for this on Sunday we could use a couple of additional Sunday volunteers. This will also go in the newsletter.
- We will place our order for SDP materials (hats, stickers, buffs for Devos) on Monday, January 16.

g. School Program Report

- Classes are filled, ready to go! Jamie is doing a great job running the program.
- Rick and his partner Susan Carson have accepted the name change to the school program which will now be referred to as the Rick Morson Nordic ski school.
- All references to the school program in our newsletter, news releases, correspondence and signage on site at Mount Washington will acknowledge Mount Washington Alpine resort, Strathcona Nordics and Richardson Wealth Morson Carson wealth management Cousel as founding organizations of the program.
- It is important for us to recognize Rick and his organization as a donor and not as a sponsor in order to remain compliant with the CRA rulings regarding charitable donations.
- I will follow up with Rick and Susan regarding their promised contribution during the annual fund raiser. Richardson Wealth will top up the donation by 50%.
- Jamie and I have written a news release for the newsletter. We are highlighting Rick Morson's history.
- We have also written a newspaper article that will be published in the Campbell River Mirror and Comox Valley Record.
- Considering making certificates with donors. Club will design, Schools might print them.
- Jamie and I will write another release for the February newsletter about the Sport Canada Grant. It deserves special mention and we would like to include some photos. The grant contract stipulates that we must post one social media post in both French and English announcing the funding. Nordiq Canada will provide a French translation of the release. The contract stipulates that all communications will be in both official languages. I think we can meet this requirement by sharing our post with the French immersion schools that are participating in our program. However, we should have a discussion as to whether or not the February release in the newsletter should also be published in French. The other communication requirement is that where possible we share our post with other divisions.



- **Action**: Will get article translated, then will get it onto the website and have a blurb circulated in the newsletter.
- The program is set to start on January 10. Instructor supply may be a bit tenuous as we have lost 2 instructors who could have provided full-time instruction. However, Jamie is prepared to go ahead with the schedule as it is. Jamie may have to provide full-time instruction, that is taking a class Tuesday Wednesday and Thursday.

4. Continuing Business

a) Driving Policy

- Scope of driving policy includes safety component, and second component being the rental (whether would/fees). Separate issues. Safety plan is in development, draft may be expected in February. Aim to have it in place for next year.
- John/Graeme have a safety plan for club vehicles and those who are driving athletes (u18) to club activities.
- John/Graeme will have safety plan next month (Exclusive of rental issues).
- b) <u>Van Rental</u>
- Still need to make decision on the rental. Collaboration with Strathcona lodge is important.
- Regarding the Rental:
 - Jeff has been intimate with the van. 8 yr old van. Need to use for our purposes, no succession plan in place, no management of the van. When getting the van back from rental, it delays our use of the van. Jeff believes pushing the van to limits would do it harm. Full of adults, driving on Buttle Lake Rd. Maybe not different than our use. No warranty, no repairs covered.
 - Jeff has reviewed the report from Paul that Carolyn reported at the last weekend.
 - Strathcona Lodge paid for two tires that were damaged.
 - Concerns around certainty about how to deal with Van when it has issues.
 - Able to use the Strathcona Lodge van when ours isn't working.
 - Concerns about the age of the van, whether "one more season" will affect the van and allow us not to sell it. Have to consider planning and protecting the asset. Do we have enough information to decide if we are renting, and the impacts on the club and the van?
 - Consider bigger picture is there a rental policy, or partner based policy.
 - o Other clubs do not rent out clubs. If rentals, only rentals to CCBC.
 - May not damage the relationship between key players and the club.
 - No financial benefit. Benefit is with our Partner, but may not be to the detriment of the relationship.
 - Discussion turned to whether we rent out at all, not necessarily whether we rent to Strathcona Lodge.



- Motion by Paul that we do <u>not</u> rent out our vehicle assets to any third party for any purposes other than CCBC or CCBC related programs. Seconded by Graeme. Jeff has abstained from the vote. Motion carried.
- Action: Wendy will inform Paul of the decision and background.
- Need to make some decisions and succession planning for the vehicles. Wendy would like to have Berend to present on the ideas around the van.
